This contest is limited to only 12 participants and we will not accept ANY entries to the contest after February 7th. Please do not show up on the meeting night expecting to compete if you have not previously signed up with Syd. Also, the format of the contest this year is different than years past. We still have the very strict time limit of 8 minutes per performance (anything over and you will be disqualified), however, we are now only requiring you to perform your set 4 times (it was previously 8 times or more). After each performance, you will be given 1 minute to break down your act and move into an "out" position. From here, you will be able to reset your routine and/or watch your competition. If your act requires anything extra (music, speakers, special close-up mat, table, etc.), please bring that on your own as the ring will not have anything to provide.

As with all of our contests, there will be a cash prize for the 1st, 2nd and 3rd place winners. The contest is limited to 12 people, and once those spots have been filled, no other entries will be allowed. Also, as mentioned before, no entries will be accepted after February 7th so DO NOT delay.

It was decided, by the Board, that to free up more meetings for magic, we would alternate the Swap Meet and Auction every year. This year it is the Auction and all members are encouraged to empty out their closets and magic trunks and bring those usable treasures they want to pass on.

The rules are simple, and designed to insure that as equal a chance for all is achieved.

First, each person wishing to auction their treasures is restricted to five lots. A lot may contain as many items as the seller wishes, but each lot will be auctioned off as a single unit. So, you may have a lot that contains five or six books, another that is just one large illusion, and a third that a combination of cards, coins, and DVDs. The choice is yours. We will be auctioning off the lots, not the separate items in the lot.

Next, each seller should include a description of the items in each lot, so the auctioneer can present it in the best possible light. The seller should also include a minimum starting bid. If you have a Zig-Zag you are not going to want to start the bid at \$1, so tell us where you want the bidding to begin. What is the minimum you will accept for your lot??

Finally, Ring 76 collects 10% of the selling price. That is the fee for services rendered. Keep that in mind when you decide on your opening bid.

The Ring is trying to secure the ability to accept credit cards, which will benefit everyone. If you

have the ability to accept credit card transactions at the Lion's Club, please contact the Treasurer, Richard Ustick at rustick@flash.net. Any other questions should be directed to him as well.

Remember, the auction is at the Ring Meeting, March 12. It is always a spirited evening with bargains and riches for all. See you there.

January Performers



How to rate your magic


Wayne Kawomoto in his online column Guide to Magic and Illusion offered Levantino's check list as a guide for reviewers of magic shows. Here's Levantino's "check list" so reviewers may evaluate and score all shows in a qualitative unbiased manner - with one point awarded for a 'yes' and zero points awarded for a 'no':

- Dr. M. disagreed with Levantino's criteria for assessing a magic performance. What do you think? This response is not meant to excite disputes but hopefully will alert interested magicians how some reviewers measure their talent.
- 1. Is the act original? DR M: If the reviewer is assessing an original version of a established routine, one might give the performance special praise. Cups and Balls and Linking Rings are classic magic and for some are a measure of the magician's capability.
- 2. Is the show engaging? DR. M: The definition of 'engaging' is a matter for interpretation. If by 'engaging' one thinks that the audience is attentive, even mesmerized.
- 3. Is the audience enjoying what they are experiencing? DR. M.: That is the purpose of any performance. Here again the definition of 'enjoy' is variable and idiosyncratic. A horror show elicits for those who like that kind of excitement to a state of 'enjoyment'.
- 4. Is the presenter always 'politically correct' (i.e. no insults or crudeness)? DR. M.: The use of the word 'always' cancels out the value of this criteria. Some shows thrive on satire, making fun of situations. Blue humor is the inverse to quality.
- 5. Does the show continually hold the audience attention (i.e. no 'flat' spots)? DR. M.: In the best of performances there will be no lag times.
- 6. Is there lots of audience participation? DR.M.: If one defines audience participation as laughing, applauding, crying, stamping etc etc this criteria has importance. A stage show aka The Phantom of the

- Opera has 'little' audience participation except as an audience. Magicians, and mentalists and some illusionists reach out to the audience to have members identify with the miracles.
- 7. Is the performance highly polished? DR. M.: If by polished, one means rehearsed, this index is a meansure of the worth of the act.



- 8. Does the audience gasp at the 'wow moments'? DR.M.: Certainly, the optimum response is that ungarded spontaneous reaction.
- 9. Does the audience regularly burst into 'unprompted' spontaneous applause? DR. M.: Another display which satisfies those on the stage.
- 10.Does the audience talk positively about the show as they leave the venue? DR.M.: The show's presenters would do well to post disguised persons in the lobby who could record the remarks of the leaving audience. Thereby, they might gain some useful insights about what was good and bad about their show.
- 11.Does the show give 'value for money'? DR. M.: How does one measure that? Are illlusionists who have a myriad of barely clad dancing girls giving more for your ticket price? There are some one man/women shows with a dearth of scenery who are worth multiple "Bravos".


