About half of the respondents felt ethics shouldn't be discussed at the general meeting. Their feeling was that it wasted their time when they

wanted to do magic and not be bored with business. They chastised me for allowing the discussion to continue so long.

The other half had the opinion that the general meeting is *absolutely* where any important issues should be discussed. The club is more than just a place to come and be entertained and never have to think or work at anything that may be less than fun. They pointed out that most other social club meetings go on much longer with much more soap box rhetoric and all of the "who's having an anniversary, birthday or other trivial, boring things". Those who chastised me for stifling the discussion said I had no business stopping an issue that many were obviously interested in discussing. (I guess I can't win!)

As president, I truly believe that I'm only a person to preside, guide, inform and carry out the consensus. I've tried not to be dictatorial. I've tried to keep discussions of policy as democratic as possible. I've often had to enforce majority opinions, even when my personal view may have been opposed to that decision. Therefore, I leave it up to the membership to let me know where you want to go with this. Board meetings are the proper venue for such discussions and are open to everyone. However, another possible solution would be a special meeting to discuss the more controversial issues. What's your opinion?

A recent article in "Magic" magazine of a magician taping Chuck Fayne's act at the Magic Castle, then performing it word for word in San Diego, sparked a heated debate on what steps the ring should take concerning members who steal the thoughts and accomplishments of others. After many suggestions, the issue was tabled until the next Board meeting, and all interested members were urged to attend.

Terry Lunceford gave the 36 members and 2 guests in attendance a report on The Magic Convention held recently in Tempe, Arizona and the high quality of talent performing there. President Jeff Marcus then presented Don Soul with his IBM International membership kit.

Elections were the final topic, and the nominating committee offered the following slate of new officers: Sherry Luft-President, Rick Waterhouse-1st Vice-President, Mark Flores-2nd Vice-President, David Lane-Treasurer, Tom LaChance-Secretary, Dick Bush-Sergeant-at-Arms, Julie Dale-Board Member, and Dick Dale-Board Member. A request to the members present for other nominations resulted in no other names being offered. The election will be held at our June Meeting.

It was then on to the magic with a highly informative "card teach-in". The members formed four groups and volunteer teachers moved from group to group demonstrating various card techniques. Tom Owen gave some examples of routines using gimmicked decks, Greg Brouelette

performed a "Psychic Twin" routine, Jeff Marcus offered a four ace revelation and a triumph, and Joe Mystic demonstrated an original poker deal routine. The teachers also explained the how-to's of their work, answered all the questions we had, and provided many useful tips.

The June meeting will feature a premeeting "Collectors' Corner" presented by J.P. Jackson at 6:30pm, followed by our general meeting. The magic session has an open theme. GUIDELINE FOR THE DISPOSITION OF PERSONAL PROPERTY

Many individuals acquire substantial holdings of personal assets over a lifetime of absorbing interest in a vocation or avocation. These assets include book collections, stamps, coins, tools, artifacts and magical apparatus. Such persons are advised to seriously contemplate the future of their collections and to make detailed instructions for the orderly disposition of their assets following their decease. This is absolutely necessary to insure the supervised dispersal of their property in accordance with their wishes.

Frequently, family and executors who are assigned the responsibility of disposing of personal property in the settlement of an estate have no familiarity with or emotional attachment to the articles involved. They are uninformed as to the historical, archival or economic value of these assets. As a result they may make hasty and unwise decisions in the dispersal of this material. They may be taken advantage of by predatory and unscrupulous parties who fast talk them into selling rare and priceless items far below their true market value.

The following guides are suggested:

- 1. Individuals should discuss with immediate family members or other responsible persons the details of their collections, including the acquisition of each item, its historical significance and a preliminary estimate of its current market value.
- 2. In drawing up their last will and testament, individuals should provide detailed instructions on the disposition of their personal property based upon a careful listing of all items.

- 3. In the absence of a detailed listing in the individual's will, provision should be made for the appointment of a panel of knowledgeable persons within national and local organizations, i.e., International Brotherhood of Magicians or Society of American Magicians and local Rings or Chapters to make a survey of the material and recommendations on its disposition.
- 4. For the executor of the estate the following guidelines are suggested:
- a. Determine the extent to which articles should be repaired, repainted or restored prior to dispersal, identifying sources of funds and amounts required as well as persons to do the work.
- b. Determine if articles have been or should be identified with a stamp or bookplate as originating in or as part of the collection of the deceased.
- c. Determine whether the disposition of the collection should be recorded in the files of appropriate national organizations for future reference and research.
- d. For gifts and bequests to museums, libraries, schools, individuals, etc., determine the conditions under which persons and organizations accept or reject these articles i.e. not for resale, etc. Note: conditions such as these may not be binding.
- e. Ascertain the wisdom and practicality of advertising the articles in appropriate national and local media.
- f. Ascertain the practicality of conducting an auction before a local or regional group with rules governing minimum bids, lot composition, disposal of remainders, etc.

We note with regret the passing of Ursula Roher's mother in Germany. All members of Ring 76 extend their sympathy to Fred and Ursula for their loss.




