
Birds Of A

Feather . . .

Do you aspire to be great or are you satisfied with where you are? Do you even know where you are in the spectrum of achieving your goals? Do you have "more" left or are you "out"?

You may have practiced until you can perform a pass or a classic force better than anyone, but what can you do with your talent? Was your ultimate goal just to do the pass or classic force better than anyone or was that just your short term goal? That is, what is your next step? You obviously must perform it in a "real world" "commercial" situation. After all, magic is a performing art form that must be presented to an audience rather than in seclusion. That is, it must not only be performed for your family or immediate circle of friends but for total strangers who will be ruthlessly objective. If your goal was just to "do the move" and have it pass the "layman test" in a demonstration of your skills, then fine, but is that really what you wanted to ultimately accomplish? You may not wish to become rich and famous and that's fine: but this article is for those who want something more. Something more gratifying than hearing someone say "Hey, you're pretty good! I sure wouldn't want to play cards with vou."

First of all, I'm making the assumption that you have goals. I mean short and long term goals with your magic that you have thought about and actually written on paper (or on the computer). You know where you want to be and what you want to earn from magic this year, in five years, and in 15 years. I also assume that you have assessed where you are now in achieving those



If you are satisfied with performing for friends or making some change on the birthday circuit and that's all you want to get out of this art, then that's fine as long as you know where you are and you don't have any larger plans. Or if you do, then you know where you are on your time line. Now some may feel that I'm stepping on their toes but that's not my intention and I'm not trying to put down anyone for wherever they may be in their career. I'm just saying that you need to assess where you are from time to time in relation to where you wanted to be at this time of your life. For example, I wanted to be a millionaire by the time I was 30. Obviously, I have reevaluated my goals and am now satisfied with where I am in life and I am on track with my new objectives. Sometimes we can't accept the reflection we see in the mirror and it's difficult to go on.

After you feel that you are ready for the next level then consider this . . . associate with those who have already achieved greatness. People who want to be successful should want to associate with successful people to learn their secrets of success. They should make it a goal to learn what paths others have taken to reach greatness. Many successful people are successful because they have surrounded themselves with competent advisors and they associate with brain trusts whose advice and suggestions they respect and use. They recognize that they can't "make it" entirely on their own. They know that we must all "stand on the shoulders of giants."

Magicians can't go to traditional classes to learn the trade like aspiring singers who can take voice lessons or a budding author who can take writing classes then develop their trade to a point where it would bring them fame and fortune. Our field is much narrower and it's

harder to learn from the greats because there are so few in relation to any other performing art form. There is a particular void of competent magicians who are willing and able to teach. It's difficult to find someone who would "take you under his wing" to share the secrets of our art. Those who have been so lucky have gone on to notoriety. As an example, look at the success of Lance Burton who studied under the tutelage of Harry Collins. This is very much an apprenticeship art.

No doubt some are successful and have reached their financial and personal goals in life with their magic, but I feel that they are missing a crucial element . . . interaction with the fraternity. Some magicians prefer to disassociate themselves from other magicians for a variety of reasons. Some feel that they don't want to share their ideas with "amateurs" who will just "rip them off" and start doing their stuff. Some feel that anything they try to teach is nothing short of "casting pearls before swine" since many amateurs just want to know secrets for the sake of knowing secrets with no intention of performing. Points well taken; however, there is something to be gained from relationships with amateurs and part time pros. For example, far and away the majority of effects/props/tricks were developed by avid hobbyists, or non professionals if you will. The working pros don't come up with all of the ideas. They are too busy performing their act and earning a living. That's not to say that they don't often improve on the original. In fact, a working pro puts in a lot of time perfecting and working the trick into a solid, "commercial" routine.

Max Maven once said something to the effect that magic is the only vocation where amateurs feel that they deserve the right to get close to professionals. Amateur singers don't feel that they can go backstage and "schmooze" with Frank Sinatra after a show in Las Vegas or go out for a drink and "hang out" with him. On the contrary, some magicians feel slighted if they can't get close to

David Copperfield. I think that it comes down to the fact that there are so few of us (an estimated 30,000 magicians in the whole world and only 10% of that number are full time pros) that we feel special enough and unique enough to allow us into his circle. Is that enough to "validate our backstage ticket"?

Short of that, you should spend time reading how they became great and what "breaks" they got or rather, made for themselves. Often it seems that someone just happened to be in the right place at the right time; however, I believe that there is no such thing as an "overnight star". They served their time and paid their dues and made their own breaks and when the time came to be in the right place at the right time, then they were ready. Being there at that time and being ready for that opportunity had to have been part of their goals.

If you have the opportunity to be an understudy with someone you consider great, then you are a lucky man. If you have the opportunity to become friends with someone great, then you are a very lucky man. However you do it, I'm still of the opinion that the more you know about the artist, the better chance you have to emulate his success.

### ASK THE PRO



Curtis R. Clark

QUESTION: How do you determine what to charge for your services? I am very frustrated by people complaining about the cost, trying to beat down my price and the like. How does a beginning Magician determine what to charge? Do you have a standard fee for restaurant work, for parlor shows and for company gatherings?

CURTIS CLARK: This is a BIG question. Realize too that some performing magicians won't discuss what they charge because others may think they're charging too little or too much

I think it depends on several different factors:

- 1. What is your time worth? You need to charge what you think you are worth; at the same time taking into account your market. If your fee is too high you will probably end up sitting at home more nights playing with your newest move or trick more often than you will perform it for a live audience (not that your wife or girlfriend isn't alive, they just may not want to see the trick done 40-50 times a night).
- 2. Feel out the prospective client when they inquire about a show.



If they mention things like "well at last year's party for Johnny the circus elephant made such a mess in our yard, but the kids really enjoyed the rock group that played after the parachute jumping contest" - this is probably a client that will be able to afford your "Deluxe" show...

- 3. Offer a couple different shows for different fees. This gives the client a couple different options with different budgets to work. They will then be deciding which show they want instead of focusing on the price for "a show" by "a magician."
- 4. For larger shows, such as corporate or company shows, you should also have a different rate schedule lined up to offer them different show options. You may want one fee for close-up strolling magic, a different show for stand-up type situations and possibly another show featuring illusions, if you do them. This gives you three different price ranges to offer your prospective clients while taking the focus off of the price and putting it on the type of magic.
- 5. For restaurant work you have to keep in mind that a restaurant is not going to pay what you would get for a private party or company show. Restaurant pay tends to be much lower. However, in exchange for the lower fee, you have a regular place to perform, develop leads and work out your new material or routines. You are doing the restaurant a favor by giving them a lower price. In exchange, get them to keep you for a set amount of time (minimum of 3 months, 6 months, whatever you think is appropriate for your situation).

The ideal thing to do is to work a restaurant on what would be your slower nights anyway. That way instead of sitting home you are making a little money and laying the groundwork for some potential future bookings. If you can get a restaurant to pay you somewhere between \$30-\$50 an hour you've got a good start - <u>but hu\$tle</u> - you can make up a lot of the difference in tips.

Bottom line is: if you are new to doing shows, start out charging a modest fee until you are sure of your capabilities. Then charge what your time and talent is worth. Only one person can decide that: YOU.

This is a tough question to answer in detail without going on forever. I hope I have given you a useful overview and, perhaps, some helpful hints.

Featured performers are Chuck Fayne, Joycee Beck, Gregory Wilson and Michael Veinbergs. This year, instead of the usual banquet, with members and guests, featuring a single magician, Ring 76 will continue its. goal of bringing more magic to San Diego by making this an "open to the public" event. All seats are reserved on a firstcome, first served basis; tickets are \$10 each and this is an adults only evening. Ring 76 members had first crack at tickets at the meeting and the following day. Tickets to the general public are on sale from Tidbits directly beginning June 12. The social hour. saw much animated conversation and brisk sales of tickets, \$710 of tickets were sold.

Other upcoming events were announced: Dan Garrett will be lecturing August 22 at the Lemon Grove Parks and Recreation Center, tickets are \$15. IBM Ring 21's A Day of Magic in Hollywood is June 22<sup>nd</sup> and Ring members were looking for car-poolers to the event. Jeff Marcus (another Ring professional magician) related stories from his recent trip to Gino Manuri's Las Vegas Close-Up at the MGM. About 200 people had shown up for the event, there were some mix ups which caused some confusion and there was much talk about the Magical Empire. Jeff's wife Peggy asked the Ring to ask Jeff who had finished in the close-up competition. Turns out, Jeff took 2nd place! Congratulations Jeff, well done.

Also announced, the Magic Castle will be inviting Ring 76 members who are not now members of the Magic Castle for a mixer at the Castle in August. Ty Smith has agreed to take the lead in coordinating transportation for members planning to attend this evening. The schedule, as of this date, is Monday, August 19<sup>th</sup>.

This meeting was also the night for an audition of a new Ring 76 member, Jeff Smith. What a delight for those of us lucky enough to attend the evening. Jeff began with a comedic routine which had the room laughing. He asked a guest to mentally select a card while he brought out his single, jumbo prediction card. He then asked another member of the audience to mentally select a card. He asked, "Wouldn't it be amazing if I successful predicted

both of your cards?" He revealed that indeed, his prediction had both mentally selected cards on it (plus the 50 unselected ones too). Jeff followed up with his torn and restored newspaper routine returning the torn newspaper to "it original" state. The state Jeff ultimately returned the torn newspaper too was that of tissue paper, big surprise.

For his pièce de résistance Jeff performed his signature piece, a routine based on the board game Clue. Jeff first selected Ty Smith as his Sheriff, to guard and protect the prediction. Ty really performed his role with vigor. Jeff then selected Greg Wauson who was charged with selecting the six suspects: 3 men, 3 women; Greg managed to get four men and two women. Each person was assigned a Clue character. Jeff had one character select what the murder weapon was, another selected which room and another selected which character. When Jeff's prediction was revealed, which had been the entire time secured by Sheriff Ty, not only were the weapon and room successfully predicted but the character, played by Jeff Marcus, was pictured on the Newspaper with headlines revealing him as the murderer! Jeff's ability to build a new routine with seemingly impossible moves, all developed around a historical trick certainly promotes him to one of our leaders in magic. Our performer Hunter. youngest and newest member of Ring 76, entertained us with a card trick where he magically removed one of the angels from the back of a selected card. Hunter openly admits that magic some times requires some help from a little smoke and mirrors.

Rich Robertson's card manipulations included losing the four aces into a shuffled deck and finding them in unexpected and astonishing ways. The final prestidigitator, Bill Monroe, amused us by vanishing a card box in full view of the entire ring, a very visual effect. Bill's finale was a gambling routine were all the Kings magically change to Aces.

Afterwards, a contingent of fourteen Ring members made their way to the Denny's in Fashion Valley and spent some more time discussing magic and the Ring. A grand evening.

mind. Testimony was even produced that he had been seen flying through the air at night and stealing the breath of babies.

In short, everyone who had ever seen him work his wonders was called to testify. That and the fanciful hearsay of the frightened masses formed the bulk of the case against him. The defense was a simple one. No contest. The defendant did not take the stand and made no statement. He watched the proceedings with a certain wry amusement. To a degree it was his greatest compliment and his greatest failure. If it hadn't been so ridiculous, the prisoner might have cried. All that we had ever seen were the simple by-products of magic. All along, we had been missing the point.

"This court is now in session. The honorable Judge Gene Questa presiding. All Rise." Judge Questa took his seat before the crowded courtroom. After the shuffles of the courtroom viewers subside, The judge begins.

"This is a most unusual case. In a sense, it is tragic. We are modern people living in a modern world. I consider it a result of mass hysteria that this statute has been dusted off. Still, a case has been brought before this court. It has been argued, and decided. Now, it has been left to me to decide the sentence for this crime. As much as my personal feelings would have me dismiss this whole nonsense, I cannot. I speak here. not for myself, but rather for this court. Before pronouncing my final sentence though, I will indulge myself one opportunity to avoid it." Quest looks the prisoner directly in his famed eyes. "Sir, you and I both know that you are a charlatan and that there is no such thing as magic or witchcraft. There is no crime because there can be no crime. Regardless, I am

about to pronounce sentence. Will you take this last opportunity to demonstrate to this court that your magic is the result of trickery, and not supernatural powers of any kind?"

For the first time during the trial, the magician looked defeated. His head hung down as he thought through this latest wrinkle. All through the trial, he could have denounced and saved himself. At any point he could have produced gidets and gadgets that explained his miracles. He could have demonstrated the subtle manipulations of hand and mind. Here was one more chance to decide. Perhaps it didn't matter. Those who believed in him would not be dissuaded and those who didn't were not his concern. Still. this might be his last chance to make them understand. steeled his will and prepared to speak, at long last, in his own defense.

A gasp went through the courtroom when he stood. Nobody expected him to address the court. Why should today be any different. His eyes swept over the courtroom as he prepared to speak. His body moved with fluid grace as he approached the bench. Many in the room crossed themselves in fear, and nobody spoke. Viewers in their homes could not understand the sense of power that this man brought to the room. Later, folks would say that it was as if he was on the verge of releasing a storm of wild magic upon the courtroom. He was tall, intense, and as menacing as a caged panther. His voice descended on the courtroom; thunder wrapped in velvet.

A woman screamed as the prisoner reached out into the air above him and quickly snatched back a small golden stone. The television cameras zoomed in on the stone and fixed on a small creature trapped within. Lawyers on both sides looked like they wanted to stop this, but seemed powerless to do so. The judge watched entranced as the prisoner's voice once again manacled his audience.

"Long ago, a fly settled upon the sap of a dying tree. He was not thrown there, not captured, but rather landed of his own free will. The fly fed upon the sticky morass. Not once did he try to escape because he did not know his danger. Slowly, much too slowly for the fly to notice, the sap surrounded its victim. Over time, the sap petrified and became this piece of amber. A prison and protection all in one.

The same thing has happened to you. You have trapped yourself. You have limited your perception. You live in cities where you can't even see the stars at night. You surround yourself with sounds and sites that keep you from seeing yourself or the world around you. You listen to radio, but don't listen to yourself. You watch television, but you have ceased to seek for universal truth. You flood yourselves with foreign substances so that your pains are numbed and

your joys muted. You have given up on a world that is crashing around us. You hope that the amber will harden around you and keep you from seeing the danger and destruction that is all around you."

The magician stared intently at his piece of amber. He let the words of his diatribe sink into the crowd. Somewhere in the courtroom a woman sobbed. Slowly the wizard drew himself up to his full height and passed one powerful hand over the piece of amber. The whine of wings, long frozen, filled the courtroom. The television audience watched in stunned silence as the camera focused on the now clear piece of amber. The prisoner suddenly looked as if his power was spent. No longer threatening, he addressed the crowd.

"It is my job to free you from these bonds. Through my magics and stories I have tried to free you, if only for a moment, to see the world outside. I've tried to help you see inside and remember the dreams that you have long forgotten. I have tried to show you hope in times of quiet desperation.

My crime is that I have failed. You ask how I do my magic... It just doesn't matter. My magic is a tangible manifestation of my faith in the mysteries of this world. Cast judgment upon me not for what I have done, but what I have not. I have tried to clear your vision, and you have seen only parlor tricks."

I still remember the day that magician was tried. I watched it on television. I think he was sentenced for all of us.
