## New Magic Shop opens in Escondido





# A tribute to a magician who changed my life

I would like to pay tribute to my mentor, Ted Angell. Born in 1905 of show business parents, his Father an actor, musician, and artist, owned a traveling Tent Show called "Angells' Comedians." He moved the show to La Mesa, Calif, in 1910.

Ted was "born in the tray of a trunk in a dressing room" making his first stage appearance at the tender age of six weeks when he was substituted for the usual rag doll used in the act. By the time he was six years old the lights, bows, lusty yells, & of course the applause from the audience had him hooked on show business as a profession.

When the family moved to La Mesa, Ted's father would do magic for the kids as a hobby, so naturally, magic had an appeal to Ted and at an early age he began doing tricks to entertain himself.

At age 16 his mother died and his father took Ted and his sister out of school, and The Tent Show went on "road" again in the eastern part of the country.

Being short in stature, about 5', he grew up playing children's parts taking the character name "Toby" and old men character parts in his father's tent show plays. He was too small for

"leading man" parts so fell into the comedy role. Ted also played violin, did comedy magic and sold candy that had a prize in every box between the acts of the tent show.

Ted also became a ventriloquist, calling his figure-you guessed it-"Toby." He also painted in oil colors. While on the road he did a large 12"x15" painting of a clown that is now one of my prize possessions.

When the stock market crash of 1929 hit, Ted's father moved back to California, but continued with the traveling Tent Stock companies in the summer and presented shows during the winter months in the community of La Mesa in his tent. In the late 1930s when Ted's father died, Ted moved to East San Diego, having some business ventures in that part of the city. It was then he met his wife Bertha (Berta). Ted served his country during WW II in the Army doing USO Shows billed as "The Wacky Magician."

He was an officer of Ring 76" in San Diego, in the late 1940s when the Ring was formed. During this period of his life he contributed greatly to magic and was appointed Territorial Vice President of Southern California in 1951.

It was sometime in 1949 that Ted became a Christian and began performing mostly Gospel Magic in church and youth groups.

It was in 1963 that Ted and his wife Berta became close friends and my mentor, starting my journey in Gospel Magic. When Ted died he left me his wonderful magic props for which I will be eternally grateful. Most of all he left me knowledge and a wonderful hobby to share with others. Ted was a man who took the time to teach me a special area of magic.

# Magic Book Review by Dr. Joel Moskowitz



"The Man Who Killed Houdini"

Many people have heard of Houdini and even know something of his untimely death at age 52. The man who had defied death succumbed to what today would be a treatable condition, a burst appendix. Lore has it that a Montreal McGill University student, acting on a boast that his body was so hardy that blows would be inconsequential, surprised Houdini with punches. A ripe infected appendix, which atypically was on his left side burst. The subsequent infection killed the man who repeatedly escaped from worldly confines.

Fewer know that Houdini anticipated his death or that a psychic predicted his doom. Even less are acquainted with the still unproven theory that Houdini was killed by vengeful mediums. Don Bell, an antiquarian book seller, and award winning writer, spent the last two decades of his life investigating the mysterious circumstances of Houdini's demise.

Although Mr. Bell died in 2003, the book, "The Man Who Killed Houdini" Vehicle Press, Canada, 260 pp, was completed by his son and published posthumously. The reader doesn't know what obsessed Mr. Bell to investigate cold leads. The most fruitful revelations came from a man, now in his 80s, "Smiley" who was actually a McGill student (the puncher J. Gordan Whitehead seems not to have been actually a McGill student) and who was present when the blows were thrown. As one might expect, the insurance company who indemnified Harry Houdini's life would have been expected to have a significant monetary interest. Double indemnity would apply if it was determined that the death was accidental. Their records support that premise. But could it be that their posture was predicated on Houdini's fame -- not wanting to deprive the much admired conjurer's wife with possibly attendant bad publicity for their firm?

Bell conjectures: could McGill students accosting Houdini, who was sitting in a lounge at the Prince of Wales in Montreal, catch him unawares,

delivering abdominal blows, followed by the incident in his dressing room where one J. Gordan Whitehead, admitted he hit Houdini as a test of his strength - were these all hired by Houdini's enemies to deliver the message of a spiritualist balancing of accounts. After all, on stage, in lectures, through books, Houdini had been on a campaign to destroy the falsehood of those who would bilk the public by alleging they could communicate with the dead.

Regrettably this is not a successful Cold Case TV story. J. Gordan Whitehead is described as a recluse, possibly a drug or alcohol addict, who died of malnutrition. He was never charged with a crime. Mr. Bell consulted with psychiatrists, psychoanalysts and graphologists, all of whom offer interesting theories but none having had any first hand contact with Mr. Whitehead; all that remains is speculation.

What is known is that following the death of his much beloved mother, Cecilia, Houdini hoped to be able to communicate with her in the beyond. Disappointment led to anger and an intense resolve to debunk those who pretended that they could communicate with the deceased. Author Bell didn't address Houdini's paradoxical behavior-on the one hand, himself, displaying supernatural abilities and, conversely, insisting that the public were gullible fools to accept the performance of spiritualists as special talents. For those who believe in an afterlife, perhaps Don Bell can ask Houdini what he thinks.

The pursuit of clues makes for an interesting read. "The Man Who KilledHoudini" by Don Bell is recommended.



#### **View from the Cheap Seats**

#### Magician vs. Gambler

#### routined table magic

This month begins a description of a routine that I cobbled together several years ago from many sources. As best as I am able, I will credit the component parts as they occur in the routine.

**Effect:** The magician weaves a tale about meeting a retired Las Vegas dealer. In the tale, the two begin to compare experiences of the way a magician might handle cards vs. the way a gambler might handle cards. After the dealer shuffles and cuts, he announces that he instantly knows the position of every card in the deck from his shuffle. He then proves his assertion by naming the top card after the shuffle and cut, the ace of clubs. The incredulous magician asks the dealer how a gambler could make use of such knowledge. The dealer demonstrates his knowledge of deck handling by executing a flawless second deal and then dealing a full house of aces/queens. The magician, stunned by what he has seen, takes the cards and demonstrates his ability by having two chosen cards instantly reverse themselves in the deck, one at a time. The dealer proclaims the magician's skill to be worthless, as it would do nothing to garner any money at the card table. The magician retorts that he would never be allowed at a card table anyway, as he could magically deal any hand he wanted at any time. Despite several shuffles and cuts during the course of the routine, the magician deals a Royal Flush in Diamonds.

Set-up: You will need a commonly available deck of cards, such as Bicycle, and a matching Ace of Clubs from an additional deck. You will also need a double-faced card that is a court card on one side

and a spot card on the other, such as the 8H backed with the KS. Lay the following stack face up on the table in the order which follows, placing each card face up on the card preceding it: AC (foot of the club closest to you), QH, AS, QC, AH, duplicate AC (foot of the club nearest you), KS, 10D, JD, QD, KD, AD, the bulk of the deck, the double-faced card with the 8H face up, and the real 8H. Check this for correctness. Then, grasp the deck at the far narrow end, and turn it over end for end and place it in the card case.

This routine is a great closer in my experience, so you might want to do a few other card tricks with a normal deck and then put the deck away to do a non-card effect. When the deck returns from the pocket, you have done a deck swap. This is also a great effect to do when someone says, "Wow, I wouldn't want to play cards with you," as you reply, "I wouldn't want to play cards with a professional gambler," and start the routine.

Routine: Bring the deck out of the pocket in the case, and remove it the same way you placed it into the card case. This means that the foot of each of the two AC cards will be facing away from you as you hold the deck face down. Execute a false overhand shuffle keeping the whole deck in position as you talk. My choice of shuffle is from The Second Now You See It, Now You Don't, by Bill Tarr, page 29. Essentially, lift the whole deck off the left hand, drop 1/4 of the cards from the top into the cupped left hand, lift the right hand, and return as if to drop or pull off another bunch. Catch the original fourth between right thumb and middle fingers as you drop a second bunch into the left hand. Pick up the original fourth on the upswing, and drop it onto the second bunch in the left hand instead of dropping the new top of the deck, restoring the original packet order. On the right hand upswing, use the left fingers to flip the "shuffled" portion to the left, and drop another fourth onto the back of the deck, thus keeping the order. On the right hand upswing, use the left thumb to push the "shuffled portion" to the right against the left fingers again, and pretend to drop a bunch of cards into the left hand, using the left thumb rub against the right hand's cards to mimic the shuffle. Finally, on the last right hand upswing, use the left fingers to push the cards to the left once more, and drop the final fourth onto the back of the deck, thus keeping the whole order intact. Follow with a false cut that does not lose a card from the top of the deck.

Suggested patter for removing the deck from the

case, doing the above shuffle, and doing the false cut: "Recently I vacationed in Las Vegas, and I met a retired casino dealer. I asked him about how much cheating he had seen in his line of work, and he told me some interesting facts."

"He said, 'Actually, the Eye in the Sky in each casino would catch players when they cheat. But if a dealer chose to team up with a player and split the winnings outside the casino after his shift, that would be hard to catch.' I asked the dealer, 'How could you cheat as a dealer?"

"He replied, 'Well, for example, as a long time professional, I can feel the position of every card in the deck after a shuffle and cut.' I said, 'That's not possible!' He said, 'Sure it is! Watch: the top card of the deck is now an Ace of Clubs.' He turned it over, and it was!"

Push off the top card of the deck, grasp it with your dealing fingers on bottom, thumb on top, and turn it over by turning your palm outwards toward the audience.

"I said, 'What could you do with such knowledge?'
He replied, 'Knowing the position of valuable cards, I could hold them in place with a second deal, and deal them to my partner. Watch.""

This pseudo second-deal comes from Bruce Elliott's Best in Magic, where he calls it No Second Deal. Turn the AC face down in reverse of the way you showed it, and drop it on top of the deck. Slowly and deliberately deal five face down cards onto the table.

"The dealer said, 'Did you catch the second deal?' I have to admit that I didn't catch it."

Turn over the sixth card exactly as you did the first card to reveal that the AC has not moved! Subtly, the foot of the duplicate card matches the foot of the original card, and strongly implies that you have done five expert second deals

"I said, 'Hey, do that again!' He said, "Sure, anything you want."

Drop the sixth card face down on top of the tabled deal. Pick up the six cards, replace on top of the deck, and perform the five card deal once again to show that the sixth card is really the AC held in place from the second deal. Then bury the duplicate AC face down into the middle of the deck, to which you can refer as "burning the card" if you so desire.

Drop the five tabled cards back onto the top of the deck.

Next month, the routine continues. Until then, perfect the shuffle, as it is very useful for other stacked deck effects.

#### New Plan for Ring Raffle at monthly meetings

For several years Ring 76 has had a nice treasury for special events like the August picnic, which was a no charge event, as well as free magic lecturers and the board of directors has not had to increase our annual dues since 1999. All of this is possible in part because of our monthly raffles at Ring meetings. The cost of purchasing magic, videotapes, DVDs and magic memorabilia has become prohibitive for us to continue as we have in the past so it has been decided that a 50/50 raffle will be held in place of the more traditional prizes we have offered in the past.

We will continue to sell tickets of \$1 each or 6 tickets for \$5. Half of the money collected each month will go to the person whose number is drawn from the basket the rest of the money will go to the Ring to help with future expenses. So the big prize each month will be cash. We will draw two additional numbers and will award some of the prizes we still have in our raffle closet. We will continue to give away all of items we have collected and purchased in the past.

Our monthly Ring raffles are important to keep the Ring rolling along and our treasury healthy. Please support these efforts if it is at all possible. We are hoping our winner each month can walk away with \$25 to \$45 dollars each month. #### A lesson in Jon Martin magic

It's not very often that there is something in magic that J.P. Jackson will say he is not sure about. But I heard him utter those words earlier this year when the two of us were inventorying the late Alton Sharpe's magic collection for Al's wife Lorraine.

We had just opened a box filled with props that were built by Jon Martin (1882–1968) Martin, who was the legendary British mechanic whose fine workmanship is highly prized by professional performers around the world. Among the many items he constructed were models of the vanishing and reappearing birdcage, the reel, and a gimmick used in conjunction with the rising cards and many other effects. Martin is relatively unknown by most magicians because his work is rare and little has been written about him.

Jon Martin was a jeweler and watchmaker by trade and enjoyed working with intricate things. He was discovered by magician Arnold De Biere, (1878-1934) from England and later toured throughout the world with his magic act. De Biere is best remembered for his vanishing birdcage, expanding die and rising cards, all props that were designed and build by Jon Martin. De Biere kept Martin a secret until shortly before De Biere's death. Once the magic fraternity learned of the talents of Jon Martin they beat a path to his door. However, Martin was just one man and could only turn out a limited number of his beautiful props at any one time. He literally worked on one magic trick at a time until the day he died.


The workmanship and rarity of his magic is what makes it so expensive and desirable today. You would never find Jon Martin items in a magic catalog. They were miniature works of art that were whispered about in the backrooms of magic emporiums around the world and were handed down from one magician to another with great pride and secrecy.

Al Sharpe worked in all of the big clubs, hotels and theaters of Europe during the reconstruction period following World War II, and became acquainted with many European performers. Over the years Al collected a number of rare and very desirable Jon Martin props, some of which Al used in his own act.

In Al's collection J.P. Jackson and I found many of the intricate reels and pulls that were designed and

manufactured with clockwork precision by Jon Martin. Our problem was lining up each reel and pull with every prop they were designed to be used

with.

There were a few fragmented notes as to what went with which piece but many times the information was misleading or nonexistent. There is one note from John Mulholland (1898-1970) talking about a reel he used in the Vanishing Birdcage effect. All of the Mulholland props were neatly wrapped in a cloth bag just as he had used them years before. But the reel for the Mulholland Biird Cage had been mixed in with a box of other reels, and we did not know which one it might be because there were several that were very much alike.

By accident last March, at the Ring 313 Swap Meet and Auction in Irvine, J.P. and I met David Alexander, a magician and, later we would learn, an expert on Jon Martin's magic. David was once a protègè of the late Senior

Frackson, a magician famous for using Martin-built props. In May of this year Alexander presented his Frackson act at the Magic Collectors Weekend in Las Vegas. J.P. and I knew the only way we were going to solve the riddle of all the Jon Martin props and apparatus in Al Sharpe's collection was to call in Alexander and ask for his help. But he had a busy schedule and it was mid-August before we could all get together and begin to solve the Martin dilemma.

It was like going back in time; the Martin props were all laid out on Lorrain Sharpe's dining room table at her home in the Laguna Hills. With notebooks, cameras and a lot of time each item was examined. The gimmicks to make each trick work were carefully lined up and put together. For instance, the vanishing and reappearing birdcage has two reels; one is fastened to the wrist, the second is attached to the leg. But most important is a tiny little handmade device that connects both of the reels so they operate in sync. J.P. and I knew this tiny piece was important but had no idea how important it was or which effect it went with.

David Alexander carefully explained how each piece worked and gave us its approximate age. Many of these items are 60 and 80 years old but are still in astonishingly good working condition. At the end of the four-

session all of the props and gimmicks were matched, we had learned how to unlock the various reels and we had heard many wonderful stories about who had owned them before and how they were used.

One day in the future these Jon Martin collectables will be for sale. They will be expensive and probably not widely advertised because those who know about them are already on a waiting list to be given a chance to purchase them. ### Coming Attractions


