But there are other benefits. In the past year, the Ring's participation in community affairs has dramatically increased. We have provided shows for children and parents at shelters for some time.

This past year, we experimented with using magic to help limited and disadvantaged children develop communication and other interactive skills which will apply to the rest of their lives.

The first of these at Rady's Children's Center was a complete success and we extended a similar program into Nativity Prep School where eight students will do their own magic show in December. The continuations of both programs will offer opportunities for member participation in teaching.

Sitting on the Ring 76 Board offers members the experience of working behind the scenes in many specific planning and action capacities. All Board positions are open to all members each election.

Our bi-annual auction (coming up in November) is a great opportunity to add material to your magic stable or to convert your no longer used items into cash.

There are plenty of reasons to be a member of

Ring 76. Whether you are a full-time pro or if you never perform but just love magic in general, the Ring is a welcoming place to enjoy the company of a part of the San Diego magic community.



# Bi-Annual Ring76 Auction Goming in November



With the Holidays quickly approaching, we could all use some extra cash. So once again it is time for you to clean out your closets, sweep from under your beds, and rummage through that trunk in your garage for those magical treasures you don't need any more. Yes, it is time for the bi-annual Ring 76 Auction.

This year the auction will be held at on our usual meeting night of November 9th at St. Bartholomew's Episcopal Church at 16275 Pomerado Road, Poway, 92064. We will start promptly at 7 pm and have a small business meeting before getting on with the auction.

#### The rules are simple:

Everyone is allowed to sell up to five lots in the first session. A "lot" may contain as many items as you would like to sell, but they are all sold for the winning bid. Individual items in a lot may not be sold separately.

For example, your first lot may consist of a large illusion while your second lot may contain fourteen books on magic that you have read to death and a sponge ball. The two lots will be auctioned off separately, and not in any particular order; The sequence of the lots put up will be at the discretion of the auctioneer. After the first session, when everyone has had a chance to auction off their initial five lots, any additional lots beyond you initial allocation can go on the block. This way, no one member can dominate the evening; Everyone gets a chance to auction off their wares.

With each lot, the member must provide a written description including any defects, missing instructions, etc., to help us generate interest, and a minimum starting bid. That is the lowest price the auctioneer will accept for the lot. Unsold lots may be re-submitted at a different minimum bid on the second cycle. Price your lots carefully. You don't want to have your Zig-Zag sold off for \$10 now, do you?

The Ring will collect 10% of the final auction price from members of the Ring. Non-Ring members are welcome to bring their items to the auction. However, they will be charged 15% of the auction price. Membership has its privileges!

#### Wizards, Inc.

Ring 76's Youth Program is in high gear! We have now had five meetings of *Wizards, Inc.*, our "magic club" at Nativity Prep Academy. Our "wizards" are eight eighth graders with an interest in magic, and in developing presentation and communication skills. Our "faculty," to date, consists of Malcolm Campbell, Joe Mystic, Bob Meigs, Jeff Sargent, and Kenny Shelton.

This is part of the program Malcolm presented to IBM, resulting in a \$1,000 grant to Ring 76, and our designation as an *'Honor Ring.''* 

In our first meeting, we taught a handful of simple tricks from Bob's magic camp at the Fair. In Sessions 2, 3, and 4, we taught six more challenging routines, one of which each "wizard" will perform in a stage show that concludes our program. In Session 5, we began the phase of preparing the "wizards" to perform – discussing delivery, attire, overcoming stage freight, on-stage persona, and other elements of performing before an audience.

So far, the program appears to be an unqualified success. The only problem is we are finding it difficult to spend our grant money! Paul Gross, owner of *Hocus Pocus*, has donated most of the magic we are distributing to the "wizards." Nativity Prep is so impressed that they have offered us a meeting place in their facilities (with a little prompting from Joe Mystic), without charge.

So all you Ring members – give Malcolm Campbell a tip of the hat for putting together a worthwhile program we can all be proud of! And thanks to all the Wizards, Inc., "faculty" – Malcolm, Joe, Bob, Jeff, and Kenny for giving the time and talent to make this fine program a success!

Each attendee was given a bag with free merchandise with a value greater than the admission fee. At the break and following the lecture, merchandise relating to the effects demonstrated, as well as many others, was for sale at very reasonable prices.

Although the event was well publicized to the Ring and several outside groups, the attendance was disappointing but that did not seem to in any way affect David's unique, entertaining and informative presentation. His material would be of value to any magician, not just those who specialize in Children's Magic.
